## 3. I will be responsible for all fees incurred.

**Tuition**: Tuition is an annual rate based on the 180 days of school. School observed holidays and teacher workdays are not included in the calculation of the annual rate. The annual rate is divided into 10 equal monthly installments from August until May. The equal monthly installment is due regardless of the number of school days in a month or days of attendance. There will be no refund due to emergency weather, early school closures, student withdrawn from school, late notification of withdrawal, change of enrollment or other unpredictable cause. Payment will always be due on the 15th of the month.

At the first instance of such behavior parent/guardian will be contacted and students will work with staff to find a resolution. At second instance parent/guardian will be contacted and a conference may be scheduled with the program director. If the behavior continues the child/ren may be removed from the program.

7. Students should not bring personal belongings such as cell phones, ipods, ipads, jewelry or Kindles. If a personal item becomes a distraction to the student or others the item will be taken and stored by a staff member. Items will only be returned to parents. Capital City school and employees are not responsible for lost, stolen, or misplaced items.

I <b>will</b> be charged a \$10 late fee for pick up from 6:06pm - 6:14pm.
I <b>will</b> be charged a \$20 late fee for pick up from 6:15pm - 6:30pm.
I will be charged a \$30 late fee plus an additional \$1/per minute for every minute after 6:30.
I will be charged a \$20 cancellation fee if I sign up for All Day Care and do not cancel my space.
I understand that my monthly tuition is always due on the 15th of the month.

I understand that my monthly tuition and any late or outstanding fees must be submitted by the 30th for my child to continue in the program.

I agree to adhere the policies outlined above. Violation of policies can lead to removal of the program and will be handled on a case by case basis.
